#### Transitioning to Head Start

#### The Transition

### At 2 years 6 months (6 months before transition)

- -Discuss placement options with EHS staff
- -Discuss needs of family & child, any special considerations

#### 5 months before transition

- -Schedule dental exam
- -Schedule immunizations and physical

#### 4 months before transition

-Ensure all screenings and assessments are up to date

#### 3 months before transition

-Choose placement

#### 2 months before transition

- -Update health records and follow-up form, nutritional assessment
- -Make a site visit

#### 1 month before transition

- -Confirm placement
- -Sign release for records to be sent
- -Attend transition plan meeting

#### At transition

-EHS will send application & child file, recent physical & immunization record, ASQ, IFSP (if needed), child's health & nutrition records



#### **Head Start Objectives**

## What is different from

#### **Early Head Start?**

- between 17-20 children; 1 teacher and 1 assistant teacher.
- Family advocates will have a caseload of 40+ children, instead of 8.
- Children learn to follow a structured schedule.
- They will begin focusing on academic goals to prepare them for kindergarten.
- Students will go outside to a chill factor/ temperature of -0 degrees F every day.
   Make sure they dress accordingly.
- When your child is absent, you need to notify the center.
- Limited busing is available at some centers.
- Meals are served family style and students eat as a group.
- Classes will rest for approximately two hours in the afternoon (full-day classroom).
- Any children with an IFSP will be transitioning to an IEP if services are still required.
